

**JEFFERSON COUNTY BOARD OF SUPERVISORS’
PROCEEDINGS
June 29, 2020**

At 8:32 A.M., Chair Hamilton called the regular meeting of the Board of Supervisors to order. This session was also held electronically in a public ZOOM meeting format.

Board members present were: Daryn Hamilton, Chairman; Dee Sandquist, Vice-Chairman; Lee Dimmitt, Supervisor.
