

**JEFFERSON COUNTY BOARD OF SUPERVISORS’  
PROCEEDINGS  
August 10, 2020**

At 8:30 A.M., Chair Hamilton called the regular meeting of the Board of Supervisors to order.

Board members present were: Daryn Hamilton, Chairman; Dee Sandquist, Vice-Chairman; Lee Dimmitt, Supervisor.

A moment of silence was taken for Dick Reed’s son.

It was moved by Dimmitt, seconded by Sandquist that the minutes for the July 27<sup>th</sup>, 2020 meeting be acknowledged. All “Aye”. Motion carried.

The Board met with Sandy Stever for a mental health department update.

The Board met with the County Engineer.

It was moved by Dimmitt, seconded by Sandquist that the following resolution be approved:

**Resolution Naming Depositories**

**RESOLUTION for Iowa COVID-19 Local Government Relief Fund**

BE IT RESOLVED, by the Jefferson County Board of Supervisors that, in accordance with the rules governing the Iowa COVID-19 Local Government Relief Fund, that the Government of Jefferson County, and its subsidiary public offices, shall follow all State and Federal guidance regulating how any funding dispersed pursuant to the Relief Fund is spent, and in the event funding dispersed is shown to have been spent outside of the guidance provided, Jefferson County assumes responsibility for repayment of funding, as well as payment of the applicable penalties and interest thereon.
