RESOLUTION FOR ESTABLISHMENT OF SERVICE "C" ROADS

Jefferson County Resolution No. 23__

WHEREAS, Jefferson County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance; and

WHEREAS, Jefferson County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, The Jefferson County Board of Supervisors after consulting with the Jefferson County Engineer, desire to designate various roads in Jefferson County on the Area Service "C" System to provide for a reduced level of maintenance in order to best utilize maintenance funds, and

WHEREAS, pursuant to Notice of Public Hearing duly published according to the Iowa Code, Public Hearing as held on the 5th day of September 2023 at 9:00 A.M. in the Board of Supervisors room at the Jefferson County courthouse, Fairfield, Iowa, to hear support and or objections from the public on roads so designated.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JEFFERSON COUNTY that this County does hereby establish the roads described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

Road Description: HENRY-JEFFERSON AVENUE FROM YALE AVE TO 225TH STREET AND 225TH STREET FROM HENRY-JEFFERSON AVENUE TO ½ MILE WEST ON 225TH STREET
