

JEFFERSON COUNTY BOARD OF SUPERVISORS' PROCEEDINGS
October 2, 2023

At 8:30 A.M., Chair Drish called the regular meeting of the Board of Supervisors to order.

Board members present were: Susie Drish, Chairman; Dee Sandquist, Vice-Chairman; Lee Dimmitt, Supervisor.

Public comments: None.

It was moved by Sandquist, seconded by Drish that the minutes for the September 25th & 27th, 2023 meetings be acknowledged. All "Aye". Motion carried.

Supervisors met with the County Engineer.

It was moved by Drish, seconded by Sandquist that the County Road Department be appointed as the County Weed Commissioner. All "Aye". Motion carried.

RESOLUTION FOR RECLASSIFICATION TO SERVICE "A" ROAD

WHEREAS, Jefferson County has received a request to reclassify a portion of 200th Street from Area Service "B" Classification to Area Service "A" Classification, and to have rock surfacing placed thereon; and

WHEREAS, Jefferson County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "A" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, The Jefferson County Board of Supervisors have established Jefferson County Code of Ordinances Chapter 6-20, for the purpose of setting regulations to govern the improvement of dirt roads prior to the placement of rock surfacing thereon;

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JEFFERSON COUNTY that this County does hereby establish the described road as an Area Service "A" road, subject to the requesting property owner performing the applicable landowner responsibilities as set forth in said Ordinance. Including payment of rock surfacing and transfer of sufficient right of way.

ROAD DESCRIPTION: A 600-foot section of Jefferson County road, named 200th Street. 1446 200th St Batavia, IA
