WHEREAS, Jefferson County desires to hire Correctional Officer, therefore,

BE IT RESOLVED by the Board of Supervisors of Jefferson County, Iowa, that the Jefferson County Sheriff is authorized to hire Correctional Officer, Garrett Houghmaster.

BE IT ALSO RESOLVED by the Board of Supervisors of Jefferson County, Iowa, that Garrett Houghmaster is hired as a Correctional Officer, in the Jefferson County Sheriff’s Office at a starting salary of \$44,154.81 annually, effective September 27th, 2023 with a start date of October 3rd, 2023.
