

JEFFERSON COUNTY BOARD OF SUPERVISORS' PROCEEDINGS
March 4, 2024

At 8:30 A.M., Chair Sanquist called the regular meeting of the Board of Supervisors to order.

Board members present were: Dee Sandquist, Chairman; Lee Dimmitt, Vice-Chairman; Susie Drish, Supervisor.

Public comments: None.

It was moved by Dimmitt, seconded by Drish that the minutes for the February 26th & 27th, 2024 meetings be acknowledged. All "Aye". Motion carried.

Supervisors met with the County Engineer.

The Board met with Matt & Dean Greiner regarding 110th St., east of Pleasant Plain.

Supervisors met with the Ambulance Director.

It was moved by Dimmitt, seconded Drish that the following resolution be approved:

RESOLUTION IN THE JEFFERSON COUNTY SHERIFF'S OFFICE

WHEREAS, Jefferson County Sheriff, per the Board of Supervisors, requests to move three Deputy Sheriff positions from the General Fund to the Rural Fund effective March 1st, 2024, therefore,

BE IT RESOLVED by the Board of Supervisors of Jefferson County, Iowa, that the Jefferson County Sheriff is authorized to move three Deputy Sheriffs; Brendon Lunsford, Angie Pohren and Justin Smith.

BE IT RESOLVED by the Board of Supervisors of Jefferson County, Iowa, that the Jefferson County Sheriff is authorized to exceed their 2023-2024 budgeted Rural Fund by \$105,000.

BE IT ALSO RESOLVED by the Board of Supervisors of Jefferson County, Iowa, that Brendon Lunsford, Angie Pohren and Justin Smith be added to Rural Fund effective March 1st, 2024, and that the Sheriff's Office 2023-2024 budgeted Rural Fund exceed \$105,000.
